Full text of the proposed Amendment

Be it Resolved by the People of the State of Ohio that Article XII, Section 3(b) be updated:

“The taxation of incomes, and the rates of such taxation may be either uniform or graduated, and may be applied to such incomes and with such exemptions as may be provided by law.” *(Current language)*

The above current language shall be replaced in its’ entirety with the following:

“The taxation of incomes shall be prohibited in the state of Ohio.” *(Proposed language)*
